Your options, rights and obligations

- Meetings:** Within the first 26 weeks: Meetings every 4 weeks.
After 26 weeks of unemployment: Meetings as needed or at least every 13 weeks.
- A-kasse participation:** Your A-kasse can participate in a joint meeting at the following meetings in the Job Center:
The 1st, 5th or 6th meeting and meetings after 16 months of unemployment.
Important: Inform the Job Center, if you don't want your A-kasse to participate.
- Transportation allowance:**
- In relation to job interviews or interviews regarding wage subsidy jobs you can apply for transportation allowance at the Job Center.
 - Travel time must be more than 1,5 hours each way.
 - Documentation:
 - Written notice regarding the job interview
 - Travel receipts
- Application form:** Please fill out the form found on www.jobnet.dk (local site)
- Activities:**
- Under 30 years of age - Activity after 13 weeks of unemployment at the latest
Between 30 and 50 years of age – Activity after 13 weeks of unemployment at the latest
Above 50 years of age Activity after 13 weeks of unemployment at the latest
- Job – part time:** *If you work a minimum of 20 hours a week, you are not required to participate in activities.
If you work less than 20 hours a week, you must participate in activities.*
- Job – full time:** **Full time (37 hours a week):**
6 weeks before anticipated job start, you are exempted from your obligation to participate in activities.
Note - questions about your job searching obligations should always be addressed to your A-kasse.
- Job - temporary:** **14 days or less** - Should be registered in "Mit fravær" on www.jobnet.dk.
- Maternity leave:** **6 weeks before** expected maternity leave you are exempted from your obligation to participate in activities and meetings at the Job Center

Booking of meetings:

You are responsible for booking your own meetings on www.jobnet.dk

• Remember that you are automatically unregistered if you exceed the time limit.

Your "Job Plan":

Before you start an agreed activity, the Job Center prepares your "Job Plan", which you must confirm at www.jobnet.dk

Retirement:

6 weeks before the date of retirement, you can apply for exemption from participating in activities.

Note - you must remain active in seeking jobs as well as checking job proposals on www.jobnet.dk

Vacation:

Must be reported via "Mit fravær" at www.jobnet.dk at least two weeks before your vacation starts – Please contact your consultant if you have any problems.

"Joblog":

You must register your job search activities in your Job log on www.jobnet.dk

In your Job log, you can:

- Organize and target your job search.
- Add network meetings
- Upload your own CV and applications as a base for a dialogue on these.

Illness:

Illness must be registered via "Mit fravær" on www.jobnet.dk

Important: Remember to register at Jobnet, when you are not ill anymore.

If you are attending a course – please remember to contact the provider as well.

Are you in a subsidized employment (løntilskud) – please remember to contact your employer.

Rotationsvikar:

Temporary for permanent employee who is attending education.

- You must have at least 6 months of unemployment
- Employment as a "rotationsvikar" cannot exceed 6 months.

Voksenlærlingeordningen:

Age requirement: 25 years or older at the beginning of the education.

6 weeks job focused education with unemployment benefits:

Realkompetencevurdering:

- Opportunity for unskilled workers above 30 years of age
- Assessment of your knowledge, skills and competences
- Get recognition/paper on the skills you have gained throughout your work.

Course: job seeking in Denmark:

The Job center will sign you up - Ask your consultant for providers.
